EDUCATION INCENTIVE FOR GIRL CHILD

- 1. Women empowerment is fundamental to the progress of the nation and the society. The government has implemented several programmes/ various schemes for empowerment of women. In this connection, the Rajya Sainik Board has instituted a new scheme to provide incentive for the education of the girl child.
- 2. As per this scheme, girl child (upto two daughters) of any ex-serviceman, who gets commissioned as an officer in Defence Services or clears Civil Services examination or clear JKAS examination would be provided an incentive of Rs 50000/-in addition to other incentives.
- 3. <u>Eligibility Conditions</u>. The eligibility conditions for the release of this grant are given below:-
 - (a) ESM/Widow should be a domicile of J&K.
 - (b) ESM/Widow should be registered with ZSWO in J&K.
 - (c) Name of the ward must be recorded in the Discharge/ Service Book.
 - (d) To be claimed within six months from the declaration of the result / before passing out from the Training Academy.
- 4. <u>Methodology</u>. The ESM / Widow will apply for the release of incentives on Application Form (DD-40) to the ZSWO concerned along with following supporting documents:-
 - (a) Photocopy of Discharge Book & Aadhaar card of the ex-serviceman/widow.
 - (b) Photocopy of joining letter issued by MoD, Recruiting Directorate.
 - (c) Jammu and Kashmir Government official Gazette Notification in case of JKAS & Govt of India official Gazette Notification in case of Civil Services (UPSC).
 - (d) Certificate issued by the concerned training institute for e.g, Institute of Management, Public Administration and Rural Development (IMPARD) J&K for JKAS, Lal Bahadur Shastri National Academy (LBSNA) Massoorie for IAS and Sardar Vallabhai Patel National Police Academy (SVPNPA) for IPS, etc where the ward is undergoing training.

- (e) Photocopy of Identity card issued to the ward by the concerned training institute like IMPARD (J&K), LBSNA (Massoorie) and SVPNPA, Hyderabad, etc.
- (f) Copy of Bank Pass Book of ESM/ Widow showing Bank A/c No, IFSC Code.
- 5. <u>Documentation</u>. ZSWOs will verify the original documents and submit the case to Rajya Sainik Board along with following supporting documents:-
 - (a) Application form (DD 40) countersigned by ZSWO.
 - (b) Photocopy of Discharge Book & Aadhaar card of the ex-serviceman/widow.
 - (c) Name of ward, DOB and Part-II Order entries will be verified from the Discharge Book of ESM.
 - (d) Copy of Bank Pass Book of ESM/Widow showing Bank A/c No, IFSC Code.
 - (e) Jammu and Kashmir Government official Gazette Notification in case of JKAS & Govt of India official Gazette Notification in case of Civil Services.
 - (f) Photocopy of joining letter issued by MoD, Recruiting Directorate.
 - (g) Certificate issued by the concerned Training Academy/Institute.
 - (h) Photocopy of Identity card issued to the ward by concerned training Institute.
- 6. <u>Processing at RSB</u>. The RSB Sectt will check the documents for correctness & process the case for approval of the Secretary RSB. Thereafter, the amount will be released to the beneficiary by ZSWO/RSB.
- 7. This policy letter be filed in the <u>Master Policy File</u>/Compendium and be <u>Handed</u> <u>Over on Relief</u> (HOOR).
