- 2. <u>Eligibility conditions</u>: The eligibility conditions for the release of these grants are given below:-
 - (a) JCOs / OR & their widows should be a domicile of J&K.
 - (b) Applicant should be registered with ZSWO in J&K.
 - (c) Name of the ward & date of birth must be recorded in the Discharge Book.
 - (d) Should have passed the exam with the percentage / CGPA as laid down.
 - (e) To be claimed within six months from the declaration of results.
- 3. <u>Methodology</u>. The JCOs /OR & their widows will apply for the release of incentives on Application Form (DD-40) to the ZSWO concerned along with following supporting documents:-
 - (a) Photocopy of Discharge Book & Aadhaar card of the JCO/OR/widow.
 - (b) Photo copy of marks sheet issued by the Board/University Authorities.
 - (c) Copy of Bank Pass Book of ESM/Widows showing Bank A/c No, IFSC Code.
- 4. <u>Documentation</u>. ZSWOs will verify the original documents and submit the case to Rajya Sainik Board along with following supporting documents:-
 - (a) Photocopy of Discharge Book & Aadhaar card of the ex-servicemen.
 - (b) Application form (DD 40) signed by Head of concerned institution and countersigned by ZSWO.
 - (c) Photo copy of marks sheet issued by the Board/University Authorities duly attested by ZSWO.

- (d) Copy of Bank Pass Book of ESM/Widows showing Bank A/c No, IFSC Code.
- (e) Certificate issued by the concerned board in case of first 20 toppers in the State Board/CBSE/ICSC etc. or the newspaper cutting wherein result is published.
- 6. <u>Processing at RSB.</u> The RSB Sectt will check the documents for correctness & process the case for approval of the Secretary RSB. Thereafter, the amount will be released to the beneficiary by ZSWO/RSB.
